Additionally, I would suggest that we ensure we are thinking about *how* practitioners and individuals might use the data - for example, the possibilities are significant and some training and education could be helpful for, say, an individual doctor or practice to understand the link between access to social services benefits like CalFresh to the individuals' health outcomes. We very much appreciate the inclusion of human services agencies, as Dr. Ghaly noted. My members saw w/ Whole Person Care that you cannot separate these aspects of one's life, and I'm glad to bring that perspective.
