



# California Health & Human Services Agency Center for Data Insights and Innovation Data Exchange Framework Stakeholder Advisory Group Meeting Summary Thursday, April 7, 2022, 10:00 a.m. to 12:30 p.m.

#### Welcome and Roll Call

John Ohanian, Chief Data Officer, California Health & Human Services, welcomed attendees and shared his excitement to be holding the first hybrid Stakeholder Advisory Group meeting where presenters, Stakeholder Advisory Group members, and members of the public were able to be present in-person.





John offered a few remarks in remembrance of Patrick Kurlej, a Data Sharing Agreement Subcommittee member who passed away. Patrick was a friendly, passionate, and dedicated member of California's health data community; he will be missed, but all Californians are better for his contributions.

Stakeholder Advisory Group Members were named and introduced via roll call.

#### Vision and Meeting Objectives

Dr. Mark Ghaly, Secretary, CalHHS, thanked Stakeholder Advisory Group Members and public attendees for their continued engagement in the Data Exchange Framework development process.

Dr. Ghaly reviewed the vision for data exchange in California and emphasized that the goal is ultimately about improving the health and wellbeing of Californians. He reiterated that the Data Exchange Framework will be technology agnostic; it will not mandate the creation of a single, statewide data "repository," and it will not recommend any specific technological solution.

Dr. Ghaly reviewed language included in AB-133 that describes the shortcomings of data exchange in California and emphasized why governance with strong state leadership and stakeholder participation is needed to ensure we advance system change while maintaining public transparency and accountability. He emphasized the need for California needed to build on national efforts, such as the Trusted Exchange Framework and Common Agreement (TEFCA), to advance data exchange throughout the state. Dr. Ghaly concluded by describing the governance model recommendation and implementation approach, under which the Data Exchange Framework would launch on July 1, 2022 with CDII managing and overseeing all aspects of governance, and, through new statute, a HIE Policy Board with an oversight role would be established in January 2023.

## **Considering a Potential Model for Governance**

Jonah Frohlich, Senior Managing Director, Manatt Health Strategies, recapped the discussion on governance that occurred during the previous Stakeholder Advisory Group meeting. He reviewed the updates to the governance functions that CalHHS made based on member input, and he acknowledged that there were differing perspectives on the form the Data Exchange Framework governance model should take.

Jonah described the governance model recommendation and implementation approach and provided examples of other governance models from California (California Emergency Medical Services Authority (CalEMSA) & Covered California) and from health information exchange networks in other states (e.g., Maryland, Michigan, New York). He concluded by reviewing four discussion questions for which Stakeholder Advisory Group Member input was being requested:





- Is additional rulemaking authority needed beyond the contracting authority granted under AB133?
- What should the scope of powers of a governance entity be?
- What are the right attributes of Policy Board members?
- Should Policy Board members subject to strict conflict of interest policies?

There was general support among Stakeholder Advisory Group Members for establishing Data Exchange Framework governance, though several members noted reservations about duplicative regulatory authority and over-regulation, particularly for smaller providers, and the potential for misalignment with federal requirements. Perspectives diverged on whether governance should rest exclusively within CalHHS or be shared with an external HIE Policy Board. Members favoring the establishment of a HIE Policy Board cited the value of its independence to advance meaningful reforms, not be subject to the priorities of a single administration, and to garner public trust and incorporate input from a broad segment of stakeholders. Members favoring the preservation of CalHHS-authority cited potential legislation-related delays as a detractor from pursuing a HIE Policy Board.

Other Stakeholder Advisory Group Member feedback on governance included:

- Include a formal role for consumers in the governance structure.
- Support for strong conflict of interest policies for HIE Policy Board members.
- Clarify how "success" was defined in evaluating the data exchange governance models in other states.
- Consider establishing a state health information network that helps move data between existing networks.

## Potential Opportunities: Regulatory and Policy

Jonah Frohlich provided a brief overview of the potential opportunities to address regulatory and policy gaps and asked Stakeholder Advisory Group Members to provide written feedback in advance of the next meeting.

## **Public Comment**

John Ohanian opened the meeting to public comment, which included:<sup>1</sup>

 Jerry Hall, CivicMapping.com, thanked the Stakeholder Advisory Group and CalHHS for their work in advancing the Data Exchange Framework. Jerry emphasized the importance of continuing to protect individuals' data and ensure various entities have the right level of access. He supported including a formal role for consumers in the governance structure, and asked CalHHS and the Stakeholder Advisory Group to consider instituting a "sunset period" of five years

on the governance structure, after which the structure would be reviewed and improved.

 John Helvey, SacValley MedShare, thanked the Stakeholder Advisory Group and CalHHS for their work in advancing the Data Exchange Framework. John encouraged CalHHS and the Stakeholder Advisory Group to revisit and consider opportunities for revising California law that governs data exchange, such as the California Medical Information Act.

## **Digital Identity Strategy Update**

Dr. Rim Cothren, Independent HIE Consultant to CDII, reviewed the statutory requirements and methodology for developing the Digital Identity Strategy, including how the Data Exchange Framework Guiding Principles supported the development process. Dr. Cothren provided an:

- Overview of definitions and national initiatives that were relevant to the Digital Identity Strategy.
- The purpose of the Digital Identity Strategy, the definition of "Digital Identity", and the proposed approach for adopting and developing standards for digital identity attributes.
- The uses of digital identities and the safeguards that will ensure that the appropriate individuals are using digital identities for specified purposes.
- The purpose, considerations, and uses for a Statewide Person Index and concepts that are related to, but not included in, the Digital Identity Strategy.

Dr. Cothren acknowledged that implementing the Digital Identity Strategy may initially increase burden on stakeholders, but would provide long-term benefits to all. He proposed several strategies to mitigate short-term costs.

Dr. Cothren concluded by summarizing and describing next steps for the Digital Identity Strategy. He asked the Stakeholder Advisory Group to provide input on the following discussion questions and requested comments by April 15<sup>th</sup>:

- Is this an appropriate first step?
- Is there value in specifying attributes in the absence of a statewide index?
- Must we adopt national standards even if they don't meet our needs?
- Should the state operate the statewide index (if created)?

Stakeholder Advisory Group member feedback on the Digital Identity Strategy included:

- General support for the Digital Identity Strategy, as outlined, and for allowing individuals to access information about their digital identity. There was also support for specifying a common set of digital identity attributes as well as the standards that will be used to do so.
- Ensure that the attributes that are included in the digital identity are evaluated for health equity implications (e.g., including address as one of the attributes may have implications for people without an address).





- Consider revisiting decision not to allow demographic information included in digital identities to be used to stratify populations for analysis since such information could be particularly beneficial for identifying disparities and for other public health initiatives.
- Consider including an estimate of the level of confidence that a digital identity correctly identifies a real person based on the number of individuals with overlapping attributes (e.g., name, date of birth, zip code) that are used as inputs for a digital identity.
- Consider the potential financial burden of implementing the digital identity strategy on safety-net providers and whether there are funding opportunities to defray those costs.
- Request for detail on who participated in the social services focus group.

## Data Sharing Agreement Subcommittee Update

John Ohanian noted that Jennifer Schwartz, who has been leading the development of the Data Sharing Agreement, was unable to join today and he would provide the update on the Data Sharing Agreement Subcommittee's activities. John reviewed the topics that were covered during the fifth Data Sharing Agreement Subcommittee meetings can be found at: <a href="https://www.chhs.ca.gov/data-exchange-framework/">https://www.chhs.ca.gov/data-exchange-framework/</a>). He also described the approach for developing and distinct purposes of the Data Sharing Agreement and the Policies and Procedures. John concluded by reviewing key milestones for the Data Sharing Agreement as well as an initial set of Policies and Procedures would be discussed by the Data Sharing Agreement Subcommittee on April 26 and by the Stakeholder Advisory Group during their next meeting on May 18<sup>th</sup>.

Stakeholder Advisory Group Members feedback on the Data Sharing Agreement Subcommittee update included:

 Request to release drafts of the DSA & initial set of Policies and Procedures as soon as possible to allow for Stakeholder Advisory Group Members to coordinate legal review.

#### **Closing Remarks**

John Ohanian reviewed project next steps and noted that the next Stakeholder Advisory Group meeting is scheduled for May 18<sup>th</sup>.

Dr. Mark Ghaly emphasized the importance of the opportunity presented by the Data Exchange Framework and thanked the Stakeholder Advisory Group for their continued efforts.
