We were told that information was going to be released last week however we only still see teh one-page flyer.	The Grants Guide that we had hoped to have posted last week is still being reviewed for ADA compliance. We expect it to be posted soon!

3	Candice Rowland	How are applicants suppose to apply for the onboarding grant if the QHIOs are not yet determined?	We are launching the two programs simultaneously (QHIO Program and Grants Program). We have incorporated information on how applicants might address naming a preferred HIO in their Onboarding application, wherein they can name an HIO (prior to it earning a Q) and if said HIO were not to earn a Q, an opportunity to make a change to an HIO who is Q'd or to switch to a TA grant with their HIO of choice.

CDII will be factoring previous TA funding (most notably HITECH funding, especially Cal-HOP) when scoring applicants.
6	Melanie Slocum# Shasta County	Will information be segregated in the system between services authorized by a parent/guardian/probation officer etc vs those authorized by the minor? Will the authorization be updated to mandate a minor age 12 and older sign for minor consent services to be included as It does not appear it has taken into account minor consent services. Stating a parent "should" have a minor 12 and older to sign. The health care provider is not permitted to inform a parent or legal guardian without the minor's consent. The provider can only share the minor's medical information with them with a signed authorization from the minor. (Health & Saf. Code §§ 123110(a), 123115(a)(1); Civ. Code §§ 56.10, 56.11).	Thank you for your question. The DSA and P&Ps often cite that the exchange must follow applicable law. I am optimistic that the terms and conditions of the DxF drive what HSSI must be shared, with the cornerstones of privacy, safety, and applicable law.
