10.	Rachel Goldberg	Does CDII have an estimate for what percentage of the \$47 million will be reserved for Round 3 when non-required signatories are eligible?	We do not. Number of applicants and level of funding are variables that we do not have a lens into yet.
11.	Lynette Beckedahl	Have any of the HQIO's been identified as of yet?	No. The CDII Qualified HIO Program timeline expects QHIOs to be named early Summer 2023. Applicants can apply for a QHIO Onboarding Grant with or without a a specific HIO named. The guidance document will provide additional information on this.

12.	Bill Carlson	Can you specify what organizations have recieved grants or you are targeting for grants? Also, are organizations with both software platforms and implementation capabilites eleigible for a grant?	Thus far, only the 8 Education Grantees have been awarded a grant and are contracted with CDII. We do plan on sharing who is awarded a grant. Rounds 1 and 2 applicants must be required signatory types.
13.	Anthony Ly	as voluntary entity, do we have to sign before applying of grants?	Hi Anthony, thanks for your question! In order for an entity to be eligible for a DSA Signatory Grant, they must be a signatory of the DSA.
14.	Anthony Ly	thank you	Of course- happy to help!
15.	Lynette Beckedahl	If you are already sharing data with an HIE and that HIE becomes a QHIO and you have signed the DSA does this satisfy the data sharing requirement?	If you use an HIE or other intermediary to facilitate data sharing, it may provide the technical capabilities for you to meet your data sharing obligations. A QHIO will have been assessed to ensure it does. However, you should still review the P&Ps to ensure you are meeting your data sharing obligations by sharing all data necessary with and through your selected HIE or intermediary. 18.	Tina Christopulos	Hi Camille, And does that include entities that fall under a larger enttity that has signed the DSA?	Hi Tina, thanks for your question! A parent organization may sign the DSA on behalf of a "subordinate organization," and in the case of determining eligiblity for this grant, this subordinate organization would be considered a signatory.
