## The Vision for Data Exchange in California

Once implemented across California, the Data Exchange Framework (DxF) will create new connections and efficiencies between health and social services providers, improving whole-person care.

The DxF is California's first-ever statewide Data Sharing Agreement (DSA) that requires the secure and appropriate exchange of health and human services information to enable providers to work together and improve an individual's health and wellbeing.







## **DxF Implementation Timeline**

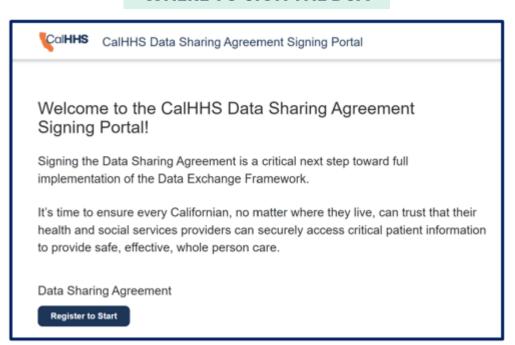

# Update on Data Sharing Agreement (DSA) Signatory Grants



## **DxF Grant Program**

Through the DxF Grant Program, CDII will administer funding to support implementation of the DxF.

### **Key Program Goals**



Support DxF implementation among DxF signatories in under-resourced geographies and/or serving historically marginalized populations and underserved communities



Address significant barriers to DxF implementation (operational, technical, or other) for DxF signatories



Align across other grant programs and promote activities ineligible for funding by other grant programs (past or present)

### **Grant Application Rounds**

Up to \$47 million in funding will be allocated to applicants across at least three rounds of funding.

CDII is holding multiple rounds to balance the 2024 deadline for some organizations to begin exchanging data while ensuring that organizations with limited resources have sufficient time to complete and submit a grant application.

Based on feedback from stakeholders, CDII has expanded eligibility for Round 2 – any DSA Signatory may apply.

## Who qualifies for DSA Signatory Grant funding?

The following criteria apply to both the QHIO Onboarding or TA Grants in Rounds 1 & 2:

(1) Must be a DSA Signatory A <u>Signatory</u> is defined as an organization that has signed the Data Sharing Agreement. Organizations may sign the DSA directly, or a "parent organization" may sign the DSA on their behalf as a "subordinate organization."

An Applicant submitting an umbrella application on behalf of multiple entities need not have signed the DSA; however, every entity included in the application must be a DSA Signatory who co-signs the grant application


(2) Must have an HIT Need

Signatory must demonstrate that they require technical support and capabilities to assist in meeting DSA requirements.



## When can I apply for a DxF Signatory Grant?

- The estimated dates of the funding rounds are:
  - Mandatory Signatories:
    - Round 1: May 16 to June 15, 2023
  - DSA Signatories (Mandatory or Voluntary):
    - Round 2: June 30 to September 1, 2023
    - Round 3 dates to be announced



 If an applicant does not receive an award during one application window, the applicant may be deferred to a future round or may be encouraged to apply in a subsequent round

## Discussion: Round 2 Outreach Strategies

CDII and its DxF Educational Grantee partners are iterating on their Round 2 Outreach Strategy to better ensure that eligible Signatories are aware and can take advantage of DSA Signatory Grant funding opportunities.

#### **Stakeholder Feedback**

Community-based organizations, counties, and other voluntary signatories have a significant need for TA and are ready to apply.

QHIOs have not been announced, making applicants hesitant to begin the QHIO Onboarding Grant process.

Stakeholders are unfamiliar with the DxF and/or DSA Signatory Grants.

### **Adjustments for Round 2**

Revised applicant eligibility criteria for Rounds 2+ onwards (Done)

Additional flexibility for QHIO Onboarding Grantees prior to the announcement of QHIOs; move Round 3 to occur after the anticipated announcement date (Done)

Educational Grantee to develop educational collateral tailored to their stakeholders




## QHIO P&P - Published (1 of 1)

### CDII has finalized and published the Qualified Health Information Organization (QHIO) P&P

### **Purpose**

The QHIO P&P establishes the Qualified HIO program, which will, among other things, establish the requirements an Intermediary must satisfy to be designated as a Qualified HIO.



The final version of this P&P has been published to the CalHHS CDII DxF website.

## **Updates to Published P&Ps**

### Process for Amending the DSA

CDII has updated the *Process for Amending the DSA* P&P to establish a more streamlined approach for making administrative changes to the DSA and to remove the requirement that signatories re-execute the DSA if it is amended.

### **Purpose**

The Process for Amending the DSA P&P describes the processes by which CDII will solicit, consider, and/or implement amendments to the DSA.

### What is changing?

- 1. Administrative Changes CDII has implemented the proposed changes to this P&P to allow administrative changes¹ to the DSA to ensure administrative consistency across the DSA and all P&Ps. Participants will have the opportunity to object to an "administrative change" during a 30-day public comment period. Standard procedures for amendments (e.g., consultation with a task force) will not be required.
- **2. Execution of Amendments** As previously discussed, the *Process for Amending the DSA* P&P has been revised to remove the requirement for Participants to execute amendments to the DSA.

### <sup>1</sup>Definition of Administration Change

An "administrative change" refers to any change that does not have a material impact on Participants, and would include, but not be limited to, changes to the definitions in the DSA to ensure consistency with the Policies and Procedures.

The final amended version of this P&P will be published to the CalHHS CDII DxF website.

### **Updates to Published P&Ps**

### Development of and Modifications to P&Ps

CDII has amended the *Development of and Modifications to P&Ps* P&P to establish a similar streamlined process for making administrative changes to P&Ps.

### **Purpose**

The Development of and Modifications to P&Ps P&P describes the processes by which CDII will develop new P&Ps and modify existing P&Ps.

### What is changing?

1. Administrative Changes CDII has amended this P&P to allow administrative changes to P&Ps to be approved on an expedited timeline. The definition of 'administrative change' is aligned between the amendments of both this P&P and the Process for Amending the DSA P&P. Participants will have the opportunity to object to an "administrative change" during a 30-day public comment period.

The final amended version of this P&P will be published to the CalHHS CDII DxF website.



## Federal Information Blocking Rules

### **Enforcement Updates**

On June 27, 2023, the US Department of Health and Human Services Office of Inspector General (HHS-OIG) released its final rule implementing information blocking penalties.

### **Overview**

- If OIG determines that an individual or entity subject to the enforcement rule committed information blocking, the individual or entity may be subject to up to a \$1 million penalty per violation.
- Actors subject to the OIG rule include:
  - Health IT developers of certified health IT;
  - Health information exchanges (HIEs); and
  - Health information networks (HINs).
- Enforcement of the OIG rule will begin September 1, 2023.
- ONC is separately establishing enforcement processes against providers by developing "provider disincentives".

## DSA P&P Glossary



## **DSA P&P Glossary**

### **Overview**

The Glossary of Defined Terms includes the definitions used in the Data Sharing Agreement (DSA) and its Policies and Procedures. These definitions have been aggregated in the Glossary as a central library of defined terms for those seeking such a reference. This glossary is a 20-page document that currently includes 70 definitions.

The initial version of the Glossary has been published to the CalHHS CDII <u>DxF website</u>. The Glossary will be updated periodically as new P&Ps are developed and to align with any amendments/edits to the DSA and existing P&Ps. The Glossary will serve as the source of truth for definitions in the DSA and P&Ps. (Note: Definitions in previously published P&Ps will be removed in a future round of administrative changes).

### Components of the DxF P&P Glossary

1. Term

The word or phrase that is defined in the DSA and/or P&Ps.

2. Definition

The meaning of each term.

3. DSA and P&P References

Lists the documents where a term is referenced.
