HHS is planning to issue a separate rule this fall that is specific to penalties for health care providers that engage in information blocking. They indicated in the enforcement rule that, depending on the specific facts and circumstances, public health institutions, clinical data registries, public health agencies, health plans and certain health care providers could meet the definition of an HIE or HIN and hence be subject to penalties for any information blocking.
