Sanjay, QHIOs are required to implement ADT capabilities over time with 3 milestones: 1 - Capability to receive ADT messages from acute care facilites by January 31, 2024 2- Capability to receive a roster of individuals to monitor for ADT events by April 30, 2024 3- Ability to match an incoming ADT event to an individual on the roster, notify the Participant who submitted the roster, and share the ADT events with other QHIOs by 7/31/2024. So, while some ADT features will start on January 31, the full complement of features will take until July 31, 2024.
