## Vision for Data Exchange in California

## The Vision for Data Exchange in California

Once implemented across California, the Data Exchange Framework (DxF) will create new connections and efficiencies between health and social services providers, improving whole-person care.

The DxF is California's first-ever statewide Data Sharing Agreement (DSA) that requires the secure and appropriate exchange of health and human services information to enable providers to work together and improve an individual's health and wellbeing.





## Who Must Sign the DSA?

#	Required Signatory Type*						
1	General acute care hospitals, as defined by Health and Safety Code (HSC) section 1250.						
2	Physician organizations and medical groups.						
3	Skilled nursing facilities, as defined by HSC section 1250, that currently maintain electronic records.						
4	Health care service plans and disability insurers that provide hospital, medical, or surgical coverage that are regulated by the Department of Managed Health Care or the Department of Insurance. This section shall also apply to a <u>Medi-Cal managed care plan under a comprehensive risk contract</u> with the Department of Health Care Services pursuant to Chapter 7 (commencing with Section 14000) or Chapter 8 (commencing with Section 14200) of Part 3 of Division 9 of the Welfare and Institutions Code that is not regulated by the Department of Managed Health Care or the Department of Insurance.						
5	Clinical laboratories, as that term is used in Section 1265 of the Business and Professions Code, and that are regulated by the Department of Public Health.						
6	Acute psychiatric hospitals, as defined by HSC section 1250.						

\*Organizations were required to sign by January 31, 2023 regardless of whether they must begin sharing data by January 31, 2024 or January 31, 2026.



## Mandatory Signatories – Sign the DSA Immediately

Mandatory Signatories were required to execute the DSA by January 31, 2023. We encourage those who have not yet signed the DSA to do so as soon as possible.

### DSA Signatory Grant Update: Round 3 is Open through December 15th

CDII is administering up to \$47M in grants to support Signatories in implementing the DxF. Round 3 is now open – DSA signatories are now invited to <u>apply through 12/15 at 11:59PM PT</u>!

CDII is holding multiple rounds to help achieve the 2024 deadline for some organizations to begin exchanging data while ensuring that organizations with limited resources have sufficient time to complete and submit a grant application.

### I signed the Data Sharing Agreement...now what?

#### Apply for DSA Signatory Grants

 DxF DSA Signatories that require additional support and capabilities to meet their DSA requirements are eligible to apply for a DSA Signatory Grant to help offset costs of relevant Technical Assistance or QHIO Onboarding investments.

#### Resource – DxF Educational Grantees

- CDII is working with DxF Educational Grantees to support signatories in meeting DxF DSA requirements.
- Organizations should reach out to one of CDII's DxF Educational Grantees (see next slide) to learn more about the DxF.

#### Prepare to Meet Data Exchange Expectations

- Broaden your knowledge of the DxF by reading the DSA and its P&Ps.
- > Understand what information you have to exchange and when you have to start exchanging
- Ensure you have the technical capabilities needed to exchange (e.g., by assessing current technology capacity and determining whether you need to upgrade or onboard new technology to meet DxF requirements).
- > Enter your information in the DxF Participant Directory.

## The Role of the QHIO

#### A QHIO is a CDII-designated data exchange intermediary that can help Participants meet the data sharing requirements of the DSA.

- The DxF is a single data sharing agreement and common set of policies and procedures that govern and require the exchange of health and social services information (HSSI).
- To participate in the DxF, signatories must be able to send and receive HSSI, locate a patient record based on person attributes, format HSSI to conform with DxF standards, meet privacy and security requirements, and more.
- For many Signatories, these are not current capabilities, and they may choose to seek the services of an Intermediary to help manage the exchange. QHIOs are Intermediaries that CDII has determined meet certain requirements that may ease the selection of an Intermediary for some Participants.
- Signatories are not required to use a QHIO however, a QHIO is a vetted source that can assist a Participant to meet the requirements of the DSA.





### Do I Need a QHIO?

- If you are a DSA Signatory and you are not sure how to exchange health and social services information with other signatories, you may benefit from the services of a QHIO
- If you are considering a QHIO, be prepared to describe your current technology solutions, whether you share information today and if so how, and your anticipated most common use cases for data exchange
- Start preparing now as data exchange for most mandatory Signatories begins January 31, 2024

### **About DSA Signatory Grants**

As part of the DxF Grant Program, CDII is administering **DSA Signatory Grants** that provide direct support to Signatories of the Data Sharing Agreement to subsidize their implementation efforts.



**Purpose:** DSA Signatory Grant funds can be used to implement a range of activities needed to achieve real-time data exchange in accordance with the DxF.



**Eligibility:** Organizations who have **signed the DSA** and demonstrate a DxF technology need are eligible for a DSA Signatory Grant.



DATA EXCHANGE FRAMEWORK

**Funding Amount:** Applicants may request between \$15,000 and \$100,000, depending on organizational characteristics, for each electronic record instance.

### **Round 3 Is Now Open**

Round 3 is now open for all required and voluntary signatories.



#### Round 3: October 16, 2023 to December 15, 2023


- > Round 3 will be open for two months.
- CDII will provide the public with notice of at least 30 days before the last round of applications closes.

### **Two Options for Applicants**

#### There are two "pathways" for organizations interested in a DSA Signatory Grant:

A Qualified Health Information Organization المعالية (QHIO) Onboarding Grants	Technical Assistance (TA) Grants
The " <b>assisted</b> " pathway for organizations seeking to onboard to a QHIO to meet many DxF requirements.	The " <b>build your own</b> " pathway for organizations seeking to address gaps in their capabilities to meet DxF requirements.
Applications are completed in partnership with <b>CAHIE</b> and submitted by <b>CAHIE</b> to CDII's TPA, Public Consulting Group, on the Applicant's behalf.	Applications are submitted by the <b>Applicant</b> to CDII's TPA, Public Consulting Group.
The Grantee's contracted <b>QHIO</b> receives and manages grant funds.	The <b>Grantee</b> receives and manages the funds directly.

Eligible organizations may apply for <u>one</u> of these two grant domains.



### **QHIOs & DSA Signatory Grants**

Signatories can use QHIO Onboarding Grants to subsidize the cost of connecting to a QHIO.

**Signatories** can select a QHIO and apply for a QHIO Onboarding Grant now.

Organizations can choose one of the nine official QHIOs announced by CDII to onboard to.

Round 1 & 2 QHIO Onboarding Grantees\*

should notify CAHIE once they have identified their QHIO to initiate the flow of funds.

\* If you have been awarded a QHIO Onboarding Grant, but your HIO of choice was not selected to become a QHIO, you have the option to convert your QHIO Onboarding Grant to a TA Grant. Please reach out to CAHIE to begin this process.


### **Umbrella Applications Encouraged**

Eligible Signatories may choose **to apply on their own,** <u>or</u> as part of an "**umbrella**" **application with other Signatories**.

An **Applicant** is the organization that submits the Application for a DSA Signatory Grant. The Applicant can be:

An eligible Signatory applying on their own behalf.

Examples include a solo physician practice, a single county, or an individual safety net hospital.



An organization applying on behalf of one or multiple eligible Signatories.

- Examples include a corporate parent, an Independent Practice Association, others.
- All DSA Signatories included in an Application must co-sign the Application.


