Overview for Applicants

DSA Signatory Grants are designed to provide direct support to Signatories of the DSA to subsize and fund activities required to meet their DSA requirements.





The Vision for Data Exchange in California

Once implemented across California, the Data Exchange Framework (DxF) will create new connections and efficiencies between health and social services providers, improving whole-person care.

The DxF is California's first-ever statewide Data Sharing Agreement (DSA) that requires the secure and appropriate exchange of health and human services information (HSSI) to enable providers to work together and improve an individual's health and wellbeing.






Understanding the DxF

DxF"Rules of the Road"

Technical Solutions *"Infrastructure"*

Data Exchange "Vehicles"







The DxF establishes "rules of the road" for exchanging data through a common Data
Sharing Agreement (DSA) and Policies & Procedures.

The DxF is not a technical solution. Each entity can choose which "road" they take to comply with DxF rules. The road represents the technologies that Participants use to exchange data. Data may travel through intermediaries, including QHIOs and national networks and frameworks, or individual technology vendors.

The DxF supports the movement of different types of clinical, administrative, and social service data or that can be exchanged using each Participant's selected technical solution in accordance with the DxF Rules of the Road.





DSA Signatory Grants are designed to provide direct support to Signatories of the DSA to subsize and fund technical solutions and activities required to meet their DSA requirements.

About DSA Signatory Grants

As part of the DxF Grant Program, CDII is administering **DSA Signatory Grants** that provide direct support to Signatories of the Data Sharing Agreement to subsidize their implementation efforts.



Purpose: DSA Signatory Grant funds can be used to implement a range of activities needed to achieve real-time data exchange in accordance with the DxF.



Eligibility: Organizations who have **signed the DSA** and demonstrate a DxF technology need are eligible for a DSA Signatory Grant.



Funding Amount: Applicants may request between \$15,000 and \$100,000, depending on organizational characteristics, for each electronic record instance.





Steps to Applying for a DSA Signatory Grant

CDII has partnered with Public Consulting Group (PCG) and the California Association of Health Information Exchanges (CAHIE) to provide hands-on support for applicants as they follow each of the following steps:



Step 1. Are you eligible for a grant?

For either the QHIO Onboarding or TA Grants, eligibility organizations are those who:

(1) Have signed the DSA.

<u>Signatories</u>* -- i.e., organizations that have signed the Data Sharing

Agreement -- are eligible for grants.

* Technology vendors who sign the DSA are not eligible for a DSA Signatory Grant.

(2) Have an HIT need to conduct data exchange.

In their application, Signatories must demonstrate that they require technical support and additional capabilities to assist in conducting data exchange in accordance with the DSA and its Policies & Procedures.



Step 2. Will you apply on your own, or with others?

Eligible Signatories may choose **to apply on their own, or** as part of an "**umbrella" application with other Signatories**.

An **Applicant** is the organization that submits the Application for a DSA Signatory Grant. The Applicant can be:



An eligible Signatory applying on their own behalf.

Examples include a solo physician practice, a single county, or an individual safety net hospital.



An organization applying on behalf of one or multiple eligible Signatories.

- Examples include a corporate parent, an Independent Practice Association, others.
- All DSA Signatories included in an Application must co-sign the Application.



Step 3. Which grant will you apply for?



Qualified Health Information Organization (QHIO) Onboarding Grant

QHIO Onboarding grants are for organizations that are already connected to an EHR and want to connect to an all-in-one solution that will establish all the infrastructure they need to conduct data exchange in accordance with the DxF.

This is an "assisted" pathway. Applicants for this grant receive support with submitting applications and managing grants.

Technical Assistance (TA) Grants

TA grants are for organizations that either **still need to connect to an EHR** (or a relevant
electronic record system for social service
organizations), or who want to **establish their own HIE solution** in order to conduct data exchange in
accordance with the DxF.

This is an "do-it-yourself" pathway. Applicants for this grant submit applications and manage grants independently.


Spotlight on QHIOs: What are they, and do I need one?

A QHIO is a health information organization that has been qualified by CDII based on its ability to meet DxF requirements.

To participate in the DxF, signatories must be able to send and receive health and social services information (HSSI), locate a patient record based on person attributes, format HSSI to conform with DxF standards, meet privacy and security requirements, and more.

For many signatories, these are not current capabilities, and they may choose to seek the services of a QHIO to help manage the exchange. Signatories are not required to use a QHIO — however, a QHIO is an organization that has attested to its capabilities to help participants meet many of the data exchange requirements of the DSA.

If you are a DSA signatory and you aren't sure how to exchange health and social services information with other signatories, you may benefit from the services of a QHIO.

QHIO Onboarding Grants

Step 4a. Applicant reaches out to CAHIE

- CAHIE will provide end-to-end application support for all QHIO onboarding applicants.
- CAHIE will determine your organizations eligibility <u>and</u> potential maximum funding request.
- If your organization decides it is interested in applying, CAHIE will request information from your organization and fill out the application for you.
 - Applicants for this grant should **not** begin their own application in the DxF Grant
 Portal (hosted on GrantsConnect) CAHIE will do it for you!

Step 5a. CAHIE submits co-signed application

 Once CAHIE has completed your application, you must review and co-sign before it is submitted.

Step 6a. Application is scored, and grants are awarded

Applications will be scored using a standard rubric after the close of each round.

Scoring Criteria

Applicants can get a higher score if they serve underserved communities or demonstrate greater need.

- 1. Signatory Characteristics
- 2. Current health IT infrastructure and capacity for HIE
- 3. Proposed activities and Funding Request
- 4. Plan for meeting DSA requirements
- 5. Plan for maintaining DSA requirements

Award Decisions

All Applications eligible for consideration in a given round will receive one of the following determinations for that round:

- Grant award
- No grant award





Step 7a. Grantee selects a QHIO

CDII announced their qualified HIOs in October 2023. Grantees can select their preferred QHIO any time between their application submission, and one year after receiving their grant or one year after QHIOs were announced by CDII, whichever is later.

What if I am already connected to an HIO?

- The Grant can be applied to your HIO as long as the HIO earned their "Q" through CDII's qualification process and you signed a new contract or contract amendment with them to achieve capabilities specific for the DxF.
- Organizations who received a QHIO Onboarding Grant prior to the QHIO announcement may be eligible to switch their funding to a TA grant if their chosen HIO does not become qualified.

Step 8a. QHIO submits progress reports and manages funds on grantee's behalf

A grantee's chosen QHIO is responsible for managing funds and submitting progress reports.

- Since the QHIO Onboarding Grant is the "assisted" pathway, the QHIOs are responsible for the management of all grant funding and reporting.
 - Grantees and QHIOs must agree on how funds will be use.
 - Prior to contracting with a QHIO, the Grantee will need to submit their own progress report.
 - o Upon contracting with a QHIO and reaching milestone 1, the selected QHIO will submit progress reports
- Grantees will be required to co-sign milestone attestation forms.



Technical Assistance Grants

Step 4b. Applicant completes their application on the DxF Grant Portal

Applicants for TA Grants should directly complete and submit their Application on the DxF Grant Portal (hosted on GrantsConnect).

Step 5b. Applicant determines funding request

FUNDING

An applicant can apply for funding based on the types of signatories under the application, and the number of instances used by those signatories.

- Signatories meeting certain criteria (like serving underserved geographies or marginalized communities) may be eligible for more funding, referred to as enhanced funding.
- Regardless of Signatory characteristics and the total number of Signatories on the Application, the total potential Application maximum is \$500,000.

Step 6b. Submitted application is scored, and grants are awarded

Once submitted, applications will be scored using a standard rubric after the close of each round.

Scoring Criteria

Applicants can get a higher score if they serve underserved communities or demonstrate greater need.

- 1. Signatory Characteristics
- Current health IT infrastructure and capacity for HIE
- 3. Proposed activities and Funding Request
- 4. Plan for meeting DSA requirements
- 5. Plan for maintaining DSA requirements

Award Decisions

All Applications eligible for consideration in a given round will receive one of the following determinations for that round:

- Grant Award
- No Grant Award

Grant Agreements

Each grantee will be required to sign a grant agreement

 Funding will be disbursed evenly across two milestones.



Step 7b. Grantee submits progress reports to receive funding

TA Grantees will be responsible for submitting progress reports each quarter until Milestone 2 is completed.

- Grantee receive funding once a progress report is submitted demonstrating the completion of TA grant milestones.
- The milestones for the TA Grant will depend on the outcomes you choose in your application.

TA Grant Outcomes

- Identifying/contracting with a technology vendor
- Onboarding costs to implement a technology solution that establishes realtime data exchange
- ✓ Adjusting, upgrading, or adopting an EHR
- Creating/providing training on workflows/processes

Appendix

Key Concepts

Signatory

A <u>Signatory</u> is defined as an organization that has signed the DSA. Organizations may sign the DSA directly, or a "parent organization" may sign the DSA on their behalf as a "subordinate organization."

A subordinate organization is considered a Signatory for the purpose of the DSA Signatory Grant Program.

Applicant

An <u>Applicant</u> is the organization that submits the Application for a DSA Signatory Grant. An Applicant may be a Signatory applying on its own behalf, or it may be an organization apply on behalf of one or multiple Signatories (referred to as an Umbrella Applicant).

Applicants are referred to as "Grantees" if they receive a DSA Signatory Grant.

Instance

An <u>Instance</u> represents a singular configuration for an electronic record system product -- which may be an electronic health record (EHR) or otherwise* -- that may exist within and/or across multiple DSA Signatories included in the Application.

*Organizations that do not have an EHR should consider their current electronic record system.

QHIO

A Qualified Health Information Organization (QHIO) is an HIO that has been "qualified" by CDII based on its ability to meet DxF data exchange requirements.

TA

Technical assistance is technological or operational support for an organization and can comprise a range of activities.
