Even better would be a description, policy by policy, as to how a QHIO would provide compliance would be ideal. As Rim stated, full implementation by the participant would be necessary to be truly compliant.

Three DxF P&Ps (Privacy and Security P&P; Permitted, Required, and Prohibited Purposes P&P; Data Elements to be Exchanged P&P) have been or are being amended to address Health and Safety Code section 130290(b)(3), which states that the DxF requirement to exchange health information in real time "shall not apply to the exchange of health information related to abortion and abortion-related services."
