We do have a selection for government, community-based organizations. Social services in the parenthesis there, data exchange intermediaries such as in HIV or HIO, an IT vendor, a trade association or advocacy organization or other.

Covering the vision for data exchange in California. Once the data exchange framework is implemented, it will create new connections and efficiencies between health and social services providers.

Including health plans to improve whole person care. The data exchange framework is the first Denver statewide data sharing agreement that requires the secure and appropriate exchange of health and human services information to enable providers to work together and improve in individuals health and well-being.

If today is the first time joining us, thank you. Now you've had a little. Tutorial on the vision of the data exchange framework and It shapes.

Many things, if not everything that we do. Required signatories. So within the health and safety code, we have a list of required signatories to sign.

General Q-care hospitals, physician organizations, and medical groups. Skilled nursing facilities, health care service and disability insurance insurers, including Medicare managed care plans, clinical labs, and acute psychiatric hospitals.

Everyone was required to sign the DSA by January 30 first. It is still open and we encourage people to sign regardless and you needed to sign regardless as to whether you're one of the entities that is able to exchange as late as January 2026.

So if you navigate to it from the links on our CDI DXF web page, you'll be comfortable and know that that is the correct portal and also on our web page is a bunch of resources.

The, and you can actually pull down the PDF of the data sharing agreement so that you can read it prior to signing.

Policies and procedures, FAQs, FAQs were updated yesterday if you're a regular attendee and you haven't seen the news flash that FAQs were updated yesterday there's new FAQs appended on to the end of the FAQ document.

So please navigate there. Meetings such as this and recordings, transcripts, a list of who has signed.

So if you're wondering who has signed, for figuring out who in your medical neighborhood or who your partners are if they have signed you can look you can see that please contact us if you have any questions or especially we have heard from people through this year that for going and navigating to look at that signatory list and not seeing their name but thinking they had signed.

And that's great information. Contact us and we help work through that a lot of the times.

It's like an Adobe signature or something pushed out that has not been received and is sitting in a created or pending status and we can help walk through that.

So DSA signing portal is a key point. So some of you might be thinking and you might have been thinking this for a while.

I've signed but now what? Prepared to meet the data exchange expectations you need to ensure that your organization is familiar and preparing to comply with the requirements in The data sharing agreement and its PNP.

So that's probably a link to take you to that section of our web page. Understand what information you have to exchange so you're not submitting information to a registry you're not doing a download and dumping information into a repository of a data hub or anything like that.

You're actually exchanging. So but what information are you exchanging? So you need to be thinking about that.

You need to know whether you're one of the entities that needs to exchange at the end of January, 24 or if you have until the opportunity to elect until 26.

Ensure that you have technical capabilities needed to exchange. And coming soon. To a DSA signing portal near you is our new screens and fields of the DXF participant directory.

So you will need to be entering your choices of what you need. Fill in the participant directory.

So definitely be paying attention this hour for information on that. The bottom is a list of some of the things in places where to go, some of the call out to the policies and procedures that will help you do some of the points that are up.

It's not to be all in all list of, okay, this is how you're compliant, but it's a very good starting place.

I'm gonna speak and introduce on the Multi-association DXF education initiative today a spotlight on this effort and we've done this in coordination with our partners, the California Academy of Family Physicians, the California Association of Health Facilities.

California Quality Collaborative. The California Association of Area Agencies on aging and K-high, California Association of Health Information exchanges.

And I want to spotlight the tremendous help we've had all along the way. From Transform Health and Blue Path Hill.

From my partners and friends Lisa Chan Sawwin and Timmy Leslie. And all of their staff.

And so with that, I'm going to turn it over to Lisa to. Show us what we've accomplished in this grant over the past year.

Thank you, Bill. As, Bill noted, Transform Health and Blue Path has been working in a conjunction with Connecting for Better Health to really do at region education broadly across the state.

[Lisa Chan-Sawin] 16:14:55

And I'm gonna speak a little bit about what the work looked like as well as where we're ending the year with.

And so it's been a tremendous effort. We've. Been really blessed to work with fantastic association partners and really who are.

Creating avenues to reach key signatories. And so we kicked off our effort at the ITP annual conference last year of this year and it was a phenomenal experience.

We've been continuing to partner with iTub, because besides the, association partners that we are working with, we are also leveraging all other avenues, understanding that the data exchange framework is a critical policy that must be proliferated across the state.

And so we've been partnering with AITA to share information through their regional convenings as well as.

Blue path and transform health have also been leading a different past CPI convenings for Cal under the HCS.

And so we leverage as many venues as possible to support and reach potential signatories. And we work very closely with each of our partner associations to leverage our current existing pathways for engagement with their membership.

This can take place in a lot of different forms. We provide education outreach at conferences at webinars.

[Lisa Chan-Sawin] 16:16:34

We hold meetings. We create a lot of communication resources to support engagement with their membership. We are depending on the partner, we also do targeted outreach.

And for example, APG, some of the targeted outreach that we've been doing in, email exchanges, newsletter, but we're also doing a phone bank using some campaign techniques and tactics.

To do outreach to APG members and to make sure that they both understand what the requirements are that they understand where they might go for help.

And to help them understand what comes next after signing the DSA, which is leading into, into implementation.

We also provide a lot of communication resources. in the form of educational fact sheets.

We've done that on both like a DXF 100, and one, grant funding opportunities.

We create monthly newsletters that we work with funding opportunities. We create monthly newsletters that we work with our association partners to distribute through their many channels.

And we're also leveraging social media to really create an environment and an echo chamber to get folks excited.

About the opportunity that DXF presents. As in our partnership with Connecting for Better Health, we're lifting and sharing a lot of these resources.

And that also includes a story bank and a speakers barrow where if a partner is looking for somebody to come and speak to them or to a group about the DXF maybe they want their hospital and they're hoping to reach another hospital partner or a sniff and hoping that another skilled nursing facility might speak to their experience.

We've been building a speakers bureau to lift up early adopters and to share experiences. Through our story bank.

And we've been tracking signatories on behalf of our association partners trying to understand sort of who is signing and where we might need to push in and do some additional targeted outreach.

Throughout this year, we've had a lot of successes and as many of you can imagine, some challenges and a lot of questions.

Oftentimes we get a lot of questions about what is the, except how is that different from the DSA or not?

How did the PNPs fit in? And invariably the conversation leads to, okay, I've signed the DSA.

Now what? Or what does this journey even look like? And so towards the end of this year, as we're wrapping up.

We are focused on development of the creation of a DXF boot camp. We've been partnering with iTub to really develop a boot cam so that we can share that with others and as coming out of that boot camp event, we have developed a toolkit.

So I which I will be talking about in just a few minutes. Next slide, please.

Technical difficulties. There we go.

Okay, not perfect. Thank you, Dean. One of the common questions that we get asked often is, geez, what does this journey really look like?

And so we've been working with technical experts across the different associations. With CDII and with different technical, to really.

Still this into a roadmap which is on your screen. Starting from even understanding what is the DXF.

How do I think about this work? You know, how do I understand and check if I'm a required signatory to signing to then planning for implementation, applying for funding and making these internal changes.

It is a high level roadmap and you know as we delve deeper and deeper with as we did more engagement.

We saw a lot of questions around. Well, what does each of these steps look like? And so from there, if we can go to the next slide, Dean, please.

Based on these conversations, we've been consolidating all the learnings from the year into an implementation toolkit.

We're really excited to be able to share this toolkit broadly and this toolkit is designed to mirror the roadmap but break down each of the steps into the key components questions activities that an organization might have to undertake to be able to complete that step.

So it's really intended to be an implementation guide and it's written from the lens of the layperson.

We're hoping that, you know, it's a guide that will support providers and organizations that are seeking to implement the DXF to understand the process, understand what, how to sign the DSA and then understand what are the steps to begin implementing it outlines some internal

planning steps on what are the types of questions and conversations that you might need to undertake internally within your organization as well as external to

your organization to understand the broader data exchange landscape in your region. What your trading partners upstream from you are downstream from you might be doing and thinking.

Around the data exchange, which QHIOs they might be engaging in and it contains explainers and checklists.

As well as some tools to support organizations as you're organizing, information internal to your organization and having these conversations with your external partners.

One of the things that we're hoping to do is, as I mentioned earlier, share it very broadly.

It's been extended to December, the twentieth at a 1159 PM. So that is next week instead of this Friday the fifteenth the new deadline to submit applications for round 3 for data sharing agreements is December, the twentieth.

Exchange framework where we have 9 QHIOs who have been named and they were announced in October of 2023 so we're working with these to prepare for the start of the exchange with these QHIOs who are intermediaries who help provide the exchange mechanism for how to exchange.

They are not required, but they're trusted and partners just like our grantees, they applied and went through a vetting process.

[DeeAnne McCallin] 16:29:27

So the implementation, timeline, all eyes are hands on deck basically for January, the 30 first, 2,024 implementation.

[DeeAnne McCallin] 16:29:37

I'm going to start moving a little quicker just in case because I especially want to get to some of the other slide lines, but.

[DeeAnne McCallin] 16:29:43

This is kind of covering a lot of what we've been covering. So looking back to 2,023 for policies and procedures we developed 5 new policies and procedures where we revised several existing policies and procedures, ones that might have been finalized in July by July of 2,022 and amended those and we developed a glossary for a defined terms which is an excellent resource and we do have that posted under

our policy and procedure section of our webpage. Looking ahead in 2024 as in January we are aiming we should be finalizing 2 new policies and procedures that are currently open for public comment.

The participant directory and the fees. We are finalizing administrative modifications to 3 other policies and procedures.

[DeeAnne McCallin] 16:30:33

And we do recognize that we will likely be developing additional PMPs if needs are identified. So that that's key if needs are identified.

[DeeAnne McCallin] 16:30:43

So policies and procedures do have its own procedure, policy and procedure on the development of and modifications to PMPs, which to myself means that the framework knows and sees that there will be policies and procedures needed in the future.

But we are really working to draw a line on the 2 new ones that are currently in development so that we have a clear starting embarkation point with the policies and procedures that are already finalized and posted and these 2 new ones that can be read.

This afternoon if you'd like. This is a list of the policies and procedures as of I think that yesterday's date.

[DeeAnne McCallin] 16:31:23

And so these are the various ones that are out there. So even some of them that might be in modification or amendment. Stand right now.

Still do have a previously finalized PMP that's on our web page. Some of them if you want to find something they might be under archive because it's under.

Where we're working on finalization of public comments on on a . And the fees and the participant directory are the 2 that are open.

[DeeAnne McCallin] 16:31:53

The new ones open for public comment Our grants program, so as you heard, the educational grantees have been doing a ton of outreach and work with certain entities and anybody helping CDI disseminate information on the data exchange framework.

And we've had 3 rounds, in anybody, helping CDI disseminate information on the data exchange framework.

[DeeAnne McCallin] 16:32:16

And we've had 3 rounds of the DSA signatory grants program, rounds one and 2 awards were announced and round 3 closes next week.

So looking ahead to 2024. If you are an awardee, if you were granted a, if you were granted a grant.

[DeeAnne McCallin] 16:32:29

Awarded a grant on your application you will have quarterly progress reports. Technical assistance grantees must do that submitting of their milestone of their progress reports themselves and if you have a QHIO onboarding grant then you your selected QHIO will do that submission on your behalf but with your signatures.

So we have some other resources on the DETAILS of the timing and the timeline that's important.

[DeeAnne McCallin] 16:32:59

For these grants and, slide here that is is really pretty heavy but it has the different milestones for the grants so how do you earn the funding for the first 50% of your grant award and how do you are in the second you earn those dollars amounts by meeting milestone one or milestone 2.

We have a grant guidance document where you can go into it. It's another long resource, forty-plus pages.

[DeeAnne McCallin] 16:33:28

But you can search for the word milestone or the word outcome. And kind of cut to some of the, specific point of areas where you're looking about.

We do have some recorded webinars on how to submit a progress report and I expect that in 2,024 we will likely be holding some other informational office hour type.

[DeeAnne McCallin] 16:33:50

And once all of the awards are out and helping people along the way with using and accessing their grant funds.

[DeeAnne McCallin] 16:33:59

The QHIO program is the qualified health information organization or Q. Qualified HIO or QHIO program.

So we developed an application and the qualification criteria. We released an application. We announced 9 QH IOs and we began develop, we're working on the development of a QHIO program, which is we're required to do by a policy and procedure.

So in 2,024 continuation and development of that program and. Building resources that will be accessible on our webpage and through our partners and everybody for helping you as DSA participants to learn about QHIOs, FAQs which were just added to our master FAQ document yesterday and there will likely be more coming and then we've heard requests for an information sheet with an overview of the

organizations. So a lot of work is underway on QHIO program and we expect a lot to be under going further and growing in 2,024.

Thanks. Dan. So Dan gets a break here for at least 3 slides. While I talk about the participant directory, health and safety code is most, you know, health and safety code, 1 3, point, 0, 2, 9, 0.

Calls for participants to provide access to or exchange information using any health information exchange network. Any health information organization or any technology that they choose as long as it meets the requirements of the DSA and its policies and procedures.

[Rim Cothren] 16:35:43

Sorry, identified in 2023 the need to establish a listing that we call the participant directory that allows participants to communicate the choices that they're making and how they will share help and social services information.

[Rim Cothren] 16:35:57

We established that there needs to be phases to implementing the participant directory over the course of the coming, several months.

[Rim Cothren] 16:36:07

And, define what phase one of the participant directory would be. And then we drafted and posted for public comment a policy procedure that establishes the requirements for CDI associated with the participant directory and the requirements of participants to share their choices with other participants.

[Rim Cothren] 16:36:28

That policy and procedure is out for public comment now and will be through Monday next week. So if you haven't had a chance to take a look at it and comment on it.

[Rim Cothren] 16:36:37

Please take a look on our website for the public comment. Opportunity. Over the course of the coming months.

[Rim Cothren] 16:36:45

We will complete the public comment period. On the draft PNP as I said that will close next Monday.

[Rim Cothren] 16:36:52

We will then publish the finalized PNP and we anticipate to do that. By mid January.

[Rim Cothren] 16:37:01

In the meantime, we've been working on the implementation. Of the participant directory. We're adding the ability for participants to add their choices to the participant directory using the DSA signing portal that you've already been or that signatories have already been using to sign the DSA.

[Rim Cothren] 16:37:19

Participants are expected to begin to begin entering their choices into the participant directory and we'll begin to publish.

[Rim Cothren] 16:37:27

Those choices as additional columns and the listing of DSA signatories that we published now providing an update to that at least weekly.

[Rim Cothren] 16:37:39

Now the specifics of implementation. Of the participant directory is still. Dependent upon public comments that we receive.

[Rim Cothren] 16:37:51

Through December eighteenth. So some of the things that you're going to see in the next couple of slides may change and respond to public response to public comment.

[Rim Cothren] 16:38:00

Also in 2024 will be establishing a plan for phase 2 as an expansion of what we're doing here in phase 2 as an expansion of what we're doing here in phase one.

Squaw on to the next slide, please. There are really some very simple questions that I want to highlight here.

[Rim Cothren] 16:38:17

So first of all, what is the participant directory? As I said before, it allows participants to communicate their choices for how they will divide access to or or exchange.

Health and social services information. And we're doing that through new fields. That will be added to the DSA signing portal and new columns to the listed DSA signatories.

[Rim Cothren] 16:38:42

That we publish now. And that will inform participants of the choices other participants have made and how they will share HS aside.

[Rim Cothren] 16:38:51

Who enters choices into the participant directory? Well, all participants are required to do that. QHIOs and other intermediaries may advise or assist participants.

[Rim Cothren] 16:39:02

But ultimately participants are responsible for their own choices, making sure that they're entered into participant directory and making sure that they're accurate and updated if any changes to their choices take place.

[Rim Cothren] 16:39:16

Want to note that participants that are choosing or electing to exercise their option. To begin exchanging in January.

[Rim Cothren] 16:39:27

Of 2026. Need not enter their choices until starting to exchange, but do need to indicate that they are exercising that option.

[Rim Cothren] 16:39:37

And what are the choices that need to be entered? Well, it's really a very short list.

[Rim Cothren] 16:39:42

You need to enter whether you're starting to exchange in 2024, 2026.

[Rim Cothren] 16:39:48

Again, whether you're exercising your option is provided. Under health and safety code. To to delay beginning to exchange until 2026.

[Rim Cothren] 16:39:57

You must enter your choice. Or how to receive requests for information. That's the query in response.

[Rim Cothren] 16:40:05

Type of exchange that's required of all participants. Your choice for how you choose to receive information delivery.

[Rim Cothren] 16:40:15

That is optional for all, participants. And how and your choice for how to receive requests for notifications for admissions and discharges.

[Rim Cothren] 16:40:28

And that's required of all hospitals and emergency department.

[Rim Cothren] 16:40:32

Let's go on to the next slide. And this gives you just an idea of what the participant directory will end up looking like.

[Rim Cothren] 16:40:40

Now, I want to. I want to emphasize here that the final production version of this may change. We're still under development now and, details of this are still subject to the public comment period.

[Rim Cothren] 16:40:54

On the left is an example of what you might see is additional fields in the DSA signing portal.

[Rim Cothren] 16:41:02

Where participants will enter their choices. For instance, a checkbox that says that. The participant is exercising their option to delay exchanging under the data, the data exchange framework until January, the 30 first, 2,026.

[Rim Cothren] 16:41:18

And then all participants are required to enter their choice of how to receive requests for information. That's the query response method.

[Rim Cothren] 16:41:28

Optionally, any participant may specify their choice for how to receive information delivery. That's the push of information that results from an order or referral.

[Rim Cothren] 16:41:40

And any participant. Excuse me, and hospitals and emergency departments are required to enter their choice.

[Rim Cothren] 16:41:48

Of how they will receive requests for notifications, have admissions and discharges. And what we anticipate is that there would be a short pick list.

[Rim Cothren] 16:41:58

For each of these choices where you can enter a QHIO, a network or framework, an intermediary, whether you will use your own technology and point-to-point connections or some other choice.

[Rim Cothren] 16:42:12

On the right hand side you see an example of how this might appear as additional peals in the listing of DSA signatories.

[Rim Cothren] 16:42:23

Where a participant ID that's assigned by the system is listed along with participant name that you've already entered.

[Rim Cothren] 16:42:30

And then your choices. First, whether you're delaying beginning to exchange information until 2026 your choices for how to receive requests for information information delivery and requests for notifications.

[Rim Cothren] 16:42:45

Will also be including information on those organizations. Voluntary organizations have chosen to terminate the DSA or organizations that are ceasing operations.

[Rim Cothren] 16:42:58

Those are not choices that would be in the application. Now let's think a little bit about how you as a participant might use this.

[Rim Cothren] 16:43:07

If you're a hospital, You would first to determine whether you're exercising your option to delay.

[Rim Cothren] 16:43:14

Based on the size of your organization and other criteria that are in health and safety code 13, 0, If you are beginning exchange before 2026.

[Rim Cothren] 16:43:25

Then you must make a choice for requests for information. You can choose whether to list a choice on how to receive information delivery.

[Rim Cothren] 16:43:36

And you must list a choice. For how you receive requests for notifications for of ADTs.

[Rim Cothren] 16:43:42

If you're an ambulatory provider such as position organization or medical group. Again, you may choose to check whether you are.

[Rim Cothren] 16:43:53

Beginning exchange in 2026 or 2024 You are required to list a choice or request for information.

[Rim Cothren] 16:44:04

Information delivery is optional. And admissions and discharges does not apply. Or plans it would be only how to receive requests for information.

[Rim Cothren] 16:44:17

And you can see as you walk through this that the requirements for every type of signatory may change, but they're really.

[Rim Cothren] 16:44:26

4 pieces of information that we're looking for.

[Rim Cothren] 16:44:30

Dean with that I think I'm turning things back over to you for a couple of poll

[DeeAnne McCallin] 16:44:34

Okay, I'm gonna call out that pretty much everything R just covered verbally and in the slides.

[DeeAnne McCallin] 16:44:42

Is in. The draft proposed PNP that's open for public comment. So if you're scratching your head and you're wondering what we're talking about or something doesn't comport.

[DeeAnne McCallin] 16:44:56

I would recommend and highly encourage you to submit comments on that. For reading the PNP, perhaps absorbing this, these slides and and this verbal to be able to give us feedback.

[DeeAnne McCallin] 16:45:11

This month so that we we can see if there's any gaps in what our vision is. But thank you Rim very much. There's a couple questions that we may be able to speak to.

[DeeAnne McCallin] 16:45:21

I'm not sure. And we'll keep moving forward. So here is a poll question. So, and this relates to one of the questions I think in the Q&A.

Is your organization required to exchange data under the data exchange framework? So that is not up to CDI to determine.

[DeeAnne McCallin] 16:45:40

And each organization has to make that and these words, especially the 2,026, comes from health and safety code 1 3 0 2 9.

[DeeAnne McCallin] 16:45:52

That was the predecessor to that was AV 133. So if you are a physician practice of fewer than 25 physicians rehab hospital long-term acute care hospital.

[DeeAnne McCallin] 16:46:04

We actually should have included in here, fewer than 100 hospital beds. But there's stratification that is the required, that that is how you know if you fit into some of these buckets.

[DeeAnne McCallin] 16:46:15

Let's see if people are like, okay, that neither of these apply to me or I'm not sure or if you think you're 24 or 26 we would love to see just very sampling here today.

[DeeAnne McCallin] 16:46:27

Let's see the results.

[DeeAnne McCallin] 16:46:31

Already, 33% believe 2024. All right. And 19%. So do you see how important this information for 2,026 is?

[DeeAnne McCallin] 16:46:42



We're not going to stop engaging with you. We're gonna get we're really gonna level up working with you once that we're into 2024, but we see that we can probably.

Cut a chunk of who we need to have complete and finish the their submissions into the participant directory based upon when and if you're not sure another 23% that's where we'll be able to start working will be receiving and doing exports from the data signing portal to see where the gaps are and be able to do some outreach.

That this is all part of our vision of our game plan. To help folks fill, will reach out to associations and stakeholder members and.

Implementation advisory committee. Members who represent certain entities if we're tracking that 23% of DSA.

[DeeAnne McCallin] 16:47:30

Signers are not sure when they're supposed to begin exchange. Thank you very much for that information.

[DeeAnne McCallin] 16:47:38

And then let's see what is. Our next one. So each participant. Will be required to enter choices into the participant directory fields.

[DeeAnne McCallin] 16:47:50

Notice that we use the word choices because you're not entering data. You are not giving the keys to your house of how to get into your electronic record system or your sales force or your project management system, you weren't just giving a choice.

Of what your medium is or what your vehicle is for exchange, you're not giving the keys to that vehicle.

[DeeAnne McCallin] 16:48:11

So it's not technical endpoint information. But if you know today which one you think you're going to be selecting and you might be an organization that has 10 different subordinates on the date on your signed DSA, some subordinate organizations, you might have 3 different ways that you receive information depending on the different questions.

[DeeAnne McCallin] 16:48:35

So you can actually select multiple answers here and that we need to be able to build that functionality into the fields that are in the signing portal.

[DeeAnne McCallin] 16:48:43

And which really does actually, believe it or not, reports to the slide of the the mock-up of what's in our test environment right now.

[DeeAnne McCallin] 16:48:52

So let's see if folks are going with the QHIO and other intermediary and nationwide network or framework their own technology which we refer to as point to point or framework, their own technology, which we refer to as point-to-point or other.

[DeeAnne McCallin] 16:49:05

We could have also put a, I sure don't know yet. But you can. Tuck that into other as well.

[DeeAnne McCallin] 16:49:10

Let's see the results.

[DeeAnne McCallin] 16:49:13

69% right now are thinking QHIOs 9% other intermediary 20% for national network, 26% own technology.

[DeeAnne McCallin] 16:49:26

This is actually not surprising. This is probably tracking from what we would have projected. So thank you everyone for providing this information and we'll all be able to see it in the participant directory weekly updates as it starts building out once we have a finalized PNP.

Thank you for responding. So continuing on with engaging stakeholders. We're of course filling this hour more than I thought we've hosted information is power webinars.

[DeeAnne McCallin] 16:49:57

We've had our grantees, our education grantees, we've had multiple documents released and solicited public comment, our FAQ and glossary are both excellent.

[DeeAnne McCallin] 16:50:09

And we've held additional town halls, town halls, and office. Hours we have.

Data exchanges in 2024 is the beginning date of the requirements to exchange per health and safety code 13, point, 0, 2, 9, is January 30 first, 2,024.

[DeeAnne McCallin] 16:50:28

We do not have the authority to move that date to change that date. We cannot move that like CDI move the deadline for grant round 3 because it's in legislation.

[DeeAnne McCallin] 16:50:37

So I would anticipate that's the date. Information is power webinar series. We will continue to be hosting these, but we are changing the cadence to about every 8 weeks.

[DeeAnne McCallin] 16:50:49

And there will be continued public comment opportunities. So we have those open right now and please be looking and provide us your feedback.

[DeeAnne McCallin] 16:50:57

That we can hopefully so now we have a couple of minutes to look at Q&A and we do have some difficult questions which we, embrace.

We might not be able to answer them, but we can take them back and see if we can find an answer.

So I did essentially address a little bit about the January 30 first timeline. It is in statute so we are not able to move that date.

It's not within the authority of CDI. Couple some similar is there any enforcement or any financial impact so at this time the data exchange framework under Cal HHS and CDI does not have that.

[DeeAnne McCallin] 16:51:46

And however our partner sister agencies and whatnot some of you may have seen some requirements in other programs like under the Department of Healthcare Services for example, and where there are some requirements in contracting on that side of the business of health the provision of health care within the state of California.

[DeeAnne McCallin] 16:52:08

So I, I would. Certainly recommend folks be looking and paying attention to things like that as well.

[DeeAnne McCallin] 16:52:17

So someone asked if their organization has an agreement with the QHIO, is there anything we should do other than signing the data sharing and.

[DeeAnne McCallin] 16:52:28

Neither one of those is a de facto okay I'm fine and I'm compliant with the de facto, okay, I'm fine and I'm compliant with the data sharing agreement.

[DeeAnne McCallin] 16:52:38

If you are required signatory, signing the DSA is a huge big first step towards being compliant.

[DeeAnne McCallin] 16:52:42

But then you need to meaningfully use it. And I used to, we, have been talking this year about having procured and licensed and purchased electronic health record technology.

[DeeAnne McCallin] 16:52:54

By Pain for that did not buy by default make you a meaningful user and I just thought of like some people may be paying for a cell phone every every month and they have their cell phone and and they're they they pay for it.

[DeeAnne McCallin] 16:53:09

But if they don't ever turn it on or they keep the ringer off, 24, over 7, they might not be using it according to how it.

[DeeAnne McCallin] 16:53:16

Other people might be thinking it. So Joining in QHIO, signing a DSA does not that those are in a sense the one signing the DSA is the baseline and then QHIO is an opportunity and an option for you to be able to be.

[DeeAnne McCallin] 16:53:34

Assured that you can do exchange under the data exchange framework, but the actual exchange of doing the framework does rest on your shoulders for the terms and conditions that are within the DSA and the policies and procedures.

[DeeAnne McCallin] 16:53:47

I hope that helps. Alrighty. The technical assistance grants are not limited to any type of. Entity or organization type.

[DeeAnne McCallin] 16:54:01

The primary eligibility for submitting for a technical assistance grant before next Wednesday is that you are a signatory to the data sharing agreement.

[DeeAnne McCallin] 16:54:11

Before you're awarded a grant. So it's not based upon the type of entity that you are.

[DeeAnne McCallin] 16:54:19

The difference between technical assistance grants and QHIO grants, well, there's a number of differences, but one of the big ones is that the funding for a technical assistance grant goes to the applicants and the funding for a QHIO onboarding grant goes to the actual named QHIO that the DSA signatory who is the benefactor of the grant funds has named and has signed off on under the grants

program. They receive the funding. So if you still want to onboard with the QHIO, but you want to be the master of your reporting and your funds.

You can submit a technical assistance grant and still spend those funds. To onboard to a QHIO.

And the QHIO grant has not closed for 2023 both domains that's a great detail I'm glad you brought that up both technical assistance and QH I/O on boarding grants under the DSA signatory program are open until next Wednesday.

What is closed is the application cycle to become a QHIO. That's what we held open in September and then we made the announcement to who a QHIO is in October and that's completely different and very different and this is not the first person that's brought this up.

That QHIO grants are still open as part of the DSA signatory grant program through next week.

And let's see where we're at. So, does anybody have any see any other questions that we should raise up on the verbal today.

And we do encourage anybody that sees the value in the benefits of the data exchange framework. And the benefits of the data exchange framework to, and if they maintain electronic health information and if they maintain electronic health information and health and social service information and health and social service information and if they maintain electronic health information and health and social service information and that are interested in electronic health information and health and social service information and never interested in this may sign the DSA as
