The Vision for Data Exchange in California

Once implemented across California, the Data Exchange Framework (DxF) will create new connections and efficiencies between health and social services providers, improving whole-person care.

The DxF is California's first-ever statewide Data Sharing Agreement (DSA) that requires the secure and appropriate exchange of health and human services information to enable providers to work together and improve an individual's health and wellbeing.

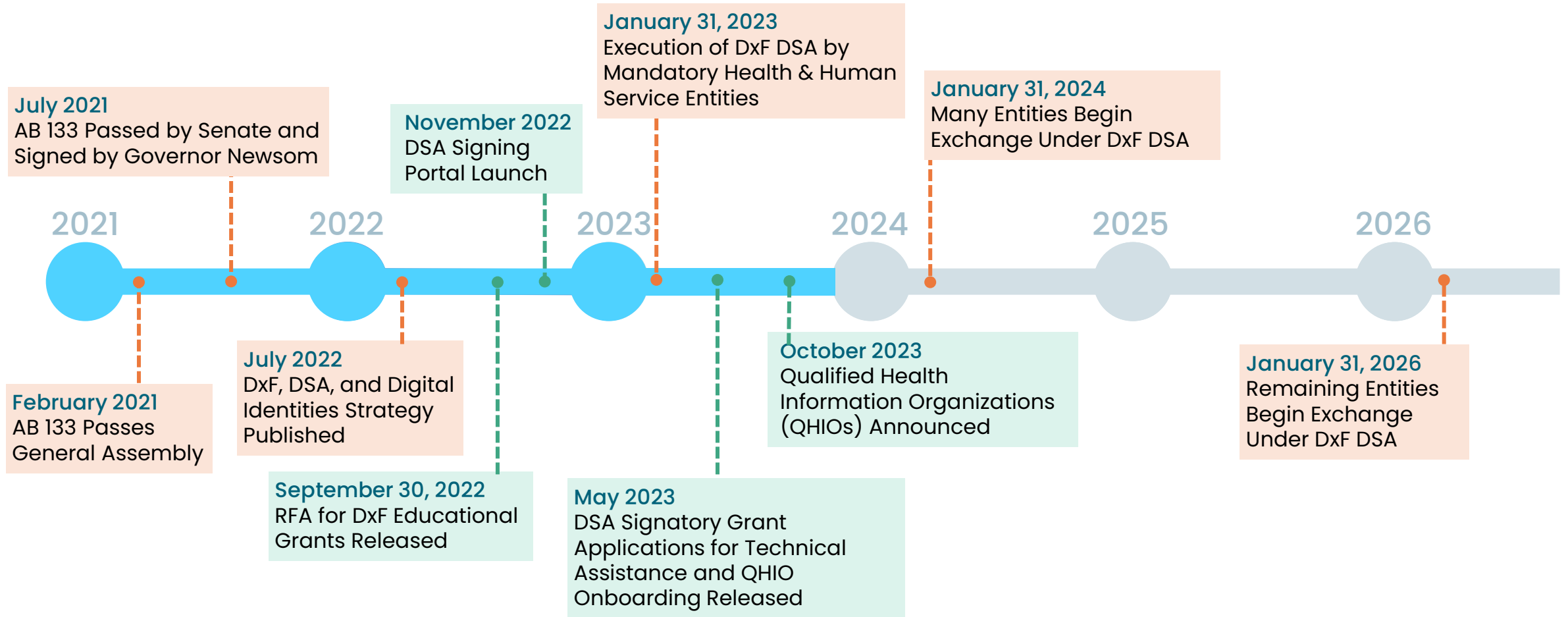

About DSA Signatory Grants

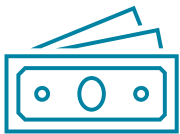
As part of the DxF Grant Program, CDII is administering **DSA Signatory Grants** that provide direct support to Signatories of the Data Sharing Agreement to subsidize their implementation efforts.



Purpose: DSA Signatory Grant funds can be used to implement a range of activities needed to achieve real-time data exchange in accordance with the DxF.



Eligibility: Organizations who have **signed the DSA** and demonstrate a DxF technology need are eligible for a DSA Signatory Grant.



Funding Amount: Applicants may request between \$15,000 and \$100,000, depending on organizational characteristics, for each electronic record instance.

 - Are some organizations still not aware of the DxF?
 - For organizations who are aware and have not signed the DSA, what is contributing to their decision not sign?
- What additional outreach and education activities are needed to address this issue?
 - What types of activities would be effective?
 - What could be provided for large audiences vs. bespoke signatory-specific education?
- Are there organizations who could work directly with providers to support them in signing the DSA? QHIIOs? Technology vendors?

Discussion on DxF Implementation to Date



Some Signatories (1) need help understanding how to meet DxF requirements, and (2) they're not clear on where to turn.

- What are major needs in the field for technical assistance in implementing the DxF?
 - Understanding the requirements and options for specific EHR systems or signatory groups?
 - Tailored support to answer questions about legal/compliance implications for organizations conducting data exchange?
 - Customized support to help Signatories understand gaps in current data exchange capabilities and options for addressing those gaps?
- What specific resources might help meet those needs?

 - ADT notifications for hospitals? SNFs?

 - County health departments/local health jurisdictions?
 - Behavioral health providers?
 - Organizations supporting individuals transitioning from incarceration?

Finalized P&Ps

CDII has finalized and released several new or amended P&Ps since the November IAC meeting.

P&P Topic	Purpose
Privacy Standards & Security Safeguards (<i>Amended</i>)	The purpose of this P&P is to help maintain the privacy, security and integrity of protected health information (PHI) or personally identifiable information (PII) and to promote trust among Participants of the DxF. It establishes the procedure by which Participants fulfill obligations to use appropriate safeguards to protect the privacy of PHI and PII, and to maintain the secure environment that supports the exchange of it.
Requirement to Exchange Health and Social Services Information (HSSI) (<i>Amended</i>)	The purpose of this P&P is to establish the responsibilities of Participants to respond to requests for Health and Social Services Information (HSSI) under the DxF.
Early Exchange (<i>New</i>)	The purpose of the P&P is to clarify the P&Ps that Participants that engage in Early Exchange must comply with regardless of the effective date set forth in such P&Ps.
Breach Notification (<i>Amended - Administrative Modifications Only</i>)	The purpose of this P&P is to establish the procedure by which Participants will fulfill their Breach notification obligations under the DSA

Data Elements to Be Exchanged

Being revised post-public comment

Overview

This P&P establishes (1) the data elements that Participants must make available to or exchange with other Participants, (2) the standards that must be used to represent that data, and (3) the formats that must be used when exchanging that data.

Purpose of the Proposed Amendment

1. Make administrative changes to align with the Glossary of Defined Terms and language used in other P&Ps drafted after the initial publication of the Data Elements to Be Exchanged P&P (among a few other things)
2. Add language recommended by DSA and P&P Subcommittee to establish precedence for data element, terminology, and data format standards
3. Clarify that Participants are not required to provide Access to or Exchange abortion or abortion-related services information in alignment with the newly signed AB 352 and its changes to HSC § 130290

Data Elements to Be Exchanged

Being revised post-public comment

Summary of Comments Received

- Received **31** comments from **seven** organizations representing providers, plans, social services, consumers, HIOs, EHR vendors, and others
- General support for proposed administrative and substantive changes
- One commenter advocated for allowing for legacy interfaces that do not conform to standards, a topic that was discussed extensively by the DSA and P&P Subcommittee but not recommended for inclusion
- Some comments suggested:
 - Separation of health information and social services information, and for specification of social services information standards beyond USCDI V2, but did not specify specific standards to include
 - Explicitly including additional specification of FHIR implementation guides compatible with already named US Core implementation guide, some for future use cases
 - Increasing readability and clarifying language, including suggestions for adjustments or additions to current content not proposed for amendment
 - Adjusting definitions in the Glossary of Defined Terms that do not impact this P&P but may be considered in future versions of the Glossary

Data Elements to Be Exchanged

Being revised post-public comment

Summary of Changes

1. Finalized P&P will retain proposed:
 - Administrative changes
 - Language that clarifies that Participants are not required to provide Access to or Exchange abortion or abortion-related services information in alignment with the newly signed AB 352
 - Language that establishes precedence for data element, terminology, and data format
2. As suggested in comments, finalized P&P will include:
 - Additional language to clarify that Participants may but are not required to provide Access to or Exchange data elements that are not yet supported by technical standards required for use by the P&P
 - Additional language to clarify that Participants may but are not required to obtain requested data elements that are not Maintained by the Participant and refers to the Technical Requirements for Exchange P&P for information on how to respond to requests for HSSI not Maintained by the Participant
 - Some clerical and wording adjustments to further align this P&P with other P&Ps, add clarity, and improve readability

Next Step: Finalize and publish the amended P&P, anticipated before the end of December 2023

Notice of Intended Administrative Changes

CDII is proposing to make certain administrative changes to three P&Ps. *CDII will accept objections to CDII's characterization of these changes as administrative through December 29, 2023 at 5pm.*



- ❖ CDII is revising the following three P&Ps to ensure consistency with the DxF Glossary of Defined Terms, clarify the use of certain terms, update references, and remove language regarding the charging of fees given the development of the new Fees P&P. These revisions should not result in any change to the meaning of the P&P, or to CDII's expectations for Participants, and are otherwise not considered to be substantive.
 - California Information Blocking Prohibitions
 - Permitted, Required, and Prohibited Purposes
 - Individual Access Services
- ❖ CDII is seeking public comment only with respect to these administrative modifications through a simplified process.
- ❖ Participants that object to CDII's determination that these changes are administrative may submit an objection for the applicable P&P(s) through online forms available on the DxF website. Objections are due by 5pm PT on December 29, 2023.

2023 Survey for Committee Members

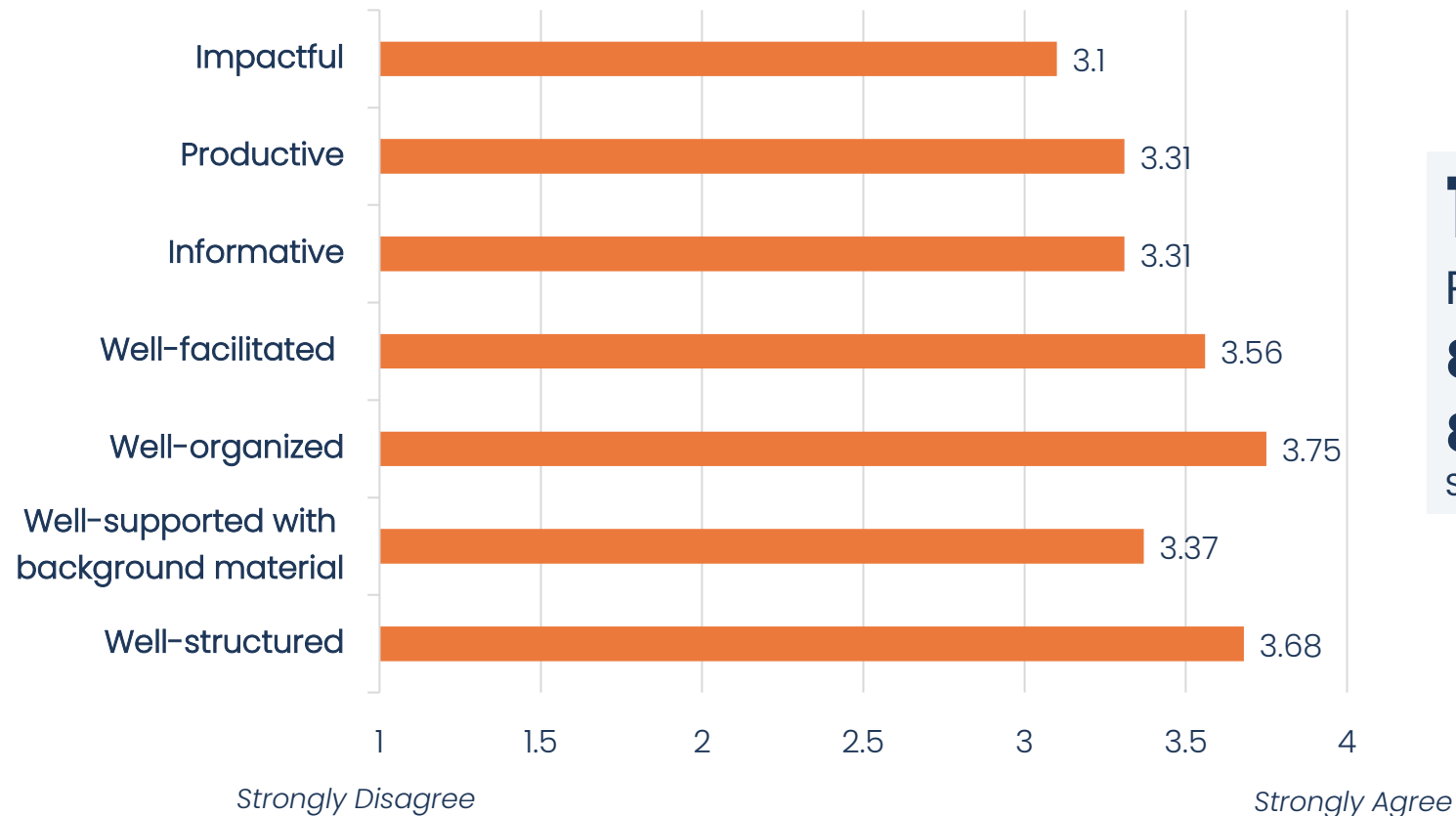
CDII extends our gratitude to Committee members for their service and dedication to the Data Exchange Framework over the past year.

2023 Survey Results

Survey Respondents provided written feedback articulating their perspectives on the committee's structure and function.

Members noted/recommended...

- *Size of their respective group was appropriate*, but recommended inclusion of more diverse perspectives and a focus on ensuring members are actively engaged.
- *Increased representation* of CBOs/social service organizations, large health systems, payers, and experts on exchange of sensitive data, AI, and health equity.
- To *focus the meeting on substantive discussion* (as opposed to the sharing of information) and increased clarity on how Committee feedback is considered to develop and inform DxF policy.
- *Future Committee topics include* metrics to measure success, interactions between the DxF and other state and federal programs and policy (e.g., TEFCA, CalAIM, information blocking rules), governance, implementation best practices and challenges, consent, and exchange with CBOs/social services organizations.

DxF Advisory Committees in 2024

Implementation Advisory Committee

CDII anticipates continuing to convene the IAC in 2024 to engage public and private stakeholders in the design and implementation of the statewide DxF.



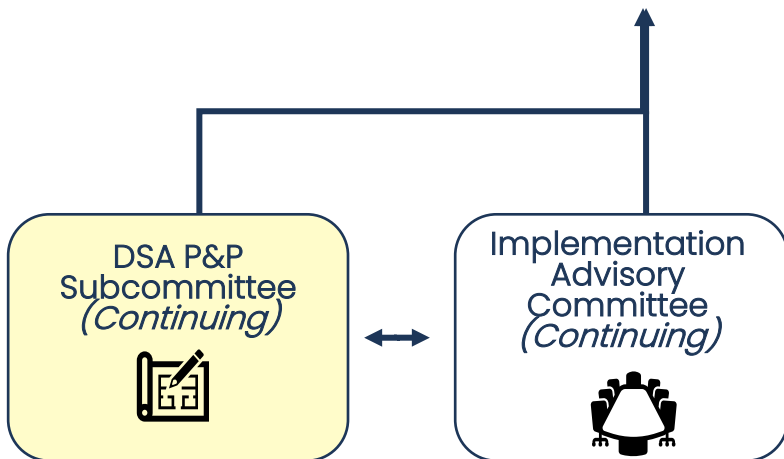
Implementation Advisory Committee (Continuing)

- **Scope:** The IAC is a chartered, multi-stakeholder advisory body that advises CDII in all aspects of DxF implementation.
- **(New) Cadence:** CDII proposes to transition IAC meetings to occur at a bi-monthly interval, spaced approximately every 8 weeks.
- **Membership:** Comprised of a broad range of public and private health care leaders and experts. CDII does not expect to change the IAC's general composition, though members may rotate on/off of the committee.

DxF Advisory Committees in 2024

Data Sharing Agreement (DSA) Policies and Procedures (P&P) Subcommittee

CDII anticipates continuing to convene the DSA P&P Subcommittee to advise CDII on the development of and modifications to DSA P&Ps.



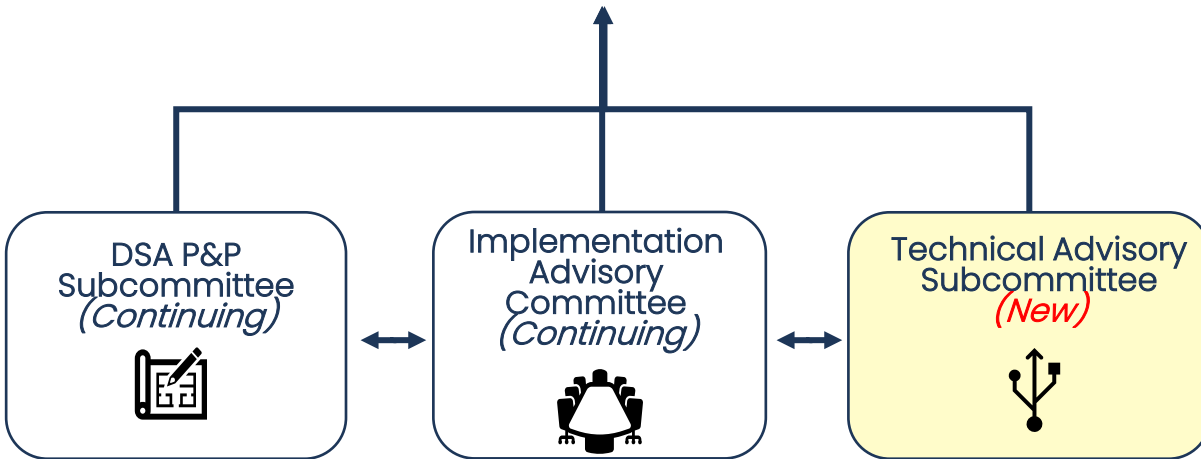
DSA P&P Subcommittee (Continuing)

- **Scope:** Serve as the primary body advising CDII in the development of, and modifications to, the DSA and its associated P&Ps. Some P&P topics requiring significant and specialized technical expertise may be socialized with the Technical Advisory Subcommittee on a limited basis.
- **(New) Cadence:** CDII proposes to transition DSA P&P SC meetings to occur at a bi-monthly interval, spaced approximately every 8 weeks.
- **Membership:** Comprised of a diverse set of public and private stakeholders with legal, technical, and operational expertise. CDII does not expect to change the DSA P&P Subcommittee's general composition, though members may rotate on/off the committee.

DxF Advisory Committees in 2024

Technical Advisory Subcommittee (TASC)

CDII proposes to establish a new subcommittee to advise CDII on DxF Implementation topics requiring significant and/or specialized technical and operational expertise.



Technical Advisory Subcommittee (New)

- **Scope:** Advise CDII on DxF implementation topics requiring significant and/or specialized technical and operational expertise. Advise on incorporation of new technical standards into DxF requirements and provide ad hoc support on other technical and implementation priorities (e.g., ADT architecture, FHIR implementation).
- **Cadence:** Multi-stakeholder advisory body with expected commitment of one year. Meetings will be held on an ad hoc basis, as needs are confirmed (likely 10-15 hours of meetings throughout the year).
- **Membership:** Comprised of technical or operational experts (e.g., with knowledge in technical specifications and exchange standards). May include individuals that also serve on the IAC or the DSA P&P Subcommittee. Membership will be fluid and subject matter experts may be onboarded as need for specific technical expertise is identified.

DxF Advisory Committees in 2024

Technical Advisory Subcommittee (TASC)

The TASC will be comprised of 10–15 Members with technical and operational expertise representing a diversity of stakeholder perspectives.

CDII anticipates that TASC Membership will include representatives from:

- Behavioral health organizations
- Clinical laboratories
- Counties
- EHR/technology vendors
- Emergency medical services
- Health plans
- Hospitals
- National networks
- QHIOs
- Physician organizations and medical groups
- Public health (state or local)
- Skilled nursing facilities
- Social services organizations (e.g., housing organization, food security organization)

Are there other perspectives that should be represented on the TASC?

DxF Oversight

CDII will continue to oversee the DxF in 2024

AB 133 required CalHHS to establish the California Health and Human Services Data Exchange Framework that includes a single data sharing agreement and common set of policies and procedures to govern and require the data exchange in California.

- CalHHS is committed to the successful implementation of the DxF, with CDII responsible for the administration, management, and oversight of the Framework
- Oversight should include responding to potential DxF violations, coordination with licensing and regulatory agencies to ensure DxF compliance, and dispute resolution
- CalHHS intends to establish a CalHHS Data Exchange Board to support review, modification and approval of the DxF's data sharing agreement and its policies and procedures
