The Vision for Data Exchange in California

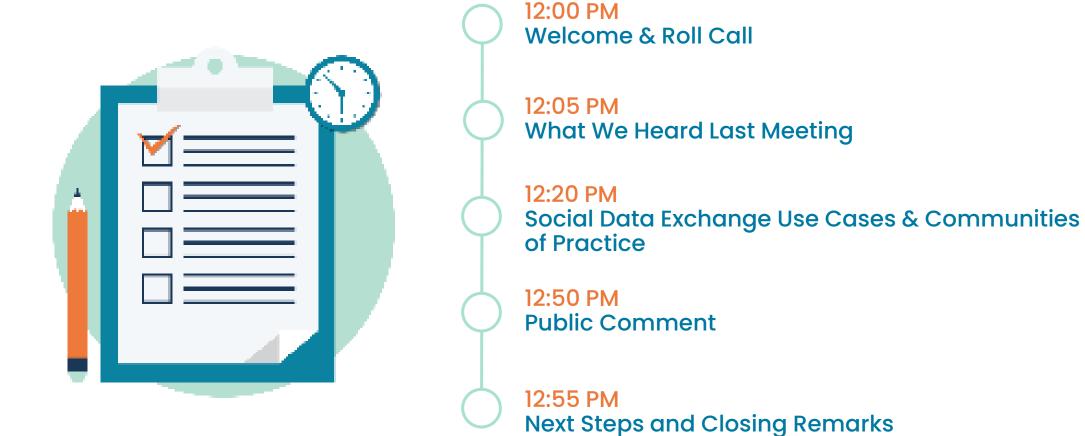
Once implemented across California, the Data Exchange Framework (DxF) will create new connections and efficiencies between health and social services providers, improving whole-person care.

The DxF is California's first-ever statewide Data Sharing Agreement (DSA) that requires the secure and appropriate exchange of health and human services information to enable providers to work together and improve an individual's health and wellbeing.

What We Heard Last Meeting

- Define use cases that will guide the development of data sharing and lead to a better understanding of who needs access to what data and when
- First determine who can access what data when, so it becomes easier to tactically apply the technology to solve data sharing between the two types of organizations
- Take a systematic approach where there are some common workflows...
 identify priority use cases that will apply within those workflows
- Capture real-time outcomes to inform care coordination and reduce duplication of services.

Establishing a Community of Practice: Homelessness Data Sharing

At the last meeting, we heard a desire to **start with specific populations and specific data**, informed by the reference capabilities to support local implementation. This approach was applied in the context of homelessness data exchange includes:

- Establishing a Community of Practice on homelessness data sharing to support current care coordination partners
 - o This approach is aligned with CalAIM ECM (managed care plans and Continuums of Care (CoCs))
 - The Community of Practice will be co-facilitated by C4BH and Homebase with a launch planned for June/July 2025
- Proposed deliverables and work products to help scale the initiative include:
 - Shared data elements for local care coordination (including data standards and translations as needed) + how access is managed
 - o Practical implementation tools (e.g., consents, access controls, APIs)
 - Local governance approaches and degree of bidirectional info sharing
