1	Lucy Johns	Thank you. I really appreciate the incredible conversation that has been going on today. I'm going to comment from my point of view as a consumer. I am a consumer on the Care Equality Steering Committee. I'm a consumer on the gravity Steering Committee. From my point of view, as a consumer patient, when I sign a consent form, I am signing consent for treatment or service. I am not signing to share my data. I happen to know, as a very well-informed consumer now, that when I signed that form, there is implicit permission to share my data. I am starting to ask When asked to sign consent Where is the provision about data sharing I would like to see it. And when I ask that, the people who give me the consent form stare blankly. They have no idea what I'm talking about. So, I would just like to layer on, all the incredible, complexity and expertise that's in evidence in this conversationI would like to layer on that patients concerned with privacy need to be thought about when thinking about consent and if it's ever possible to put consent into two huge buckets, treatment service, sharing of information. Please think about that. Thank you.
2	Lisa Nelson	Hi, this is Lisa Nelson, and I'm here from the Direct Trust community. I also participate heavily in the HL7 community and on the CDA management group. And on July 30th and 31st, we're going to be having an implementation-a-thon and there's a workshop session that's going to be focusing on managing consent documents and exchanging consent documents. And I was just super interested in the work, especially that David Mccann was talking about where there are consent documents that already exist in are already in production use to see if he or anyone else would be willing to supply some examples of consent documents that are already in use, so that we could use them as some of the focus of this workshop to scratch our heads and say "How do we exchange documents like this"?
3	Lindsey Lopez	Thanks, Alice. Hey everyone, this is Lindsay Lopez from Kaiser Permanente. I think this was a really great discussion,
