

2025-26 Edition California Health Care Quality Report Cards – Health Plan Report Card Summary of Changes

This document summarizes key changes to the upcoming 2025-26 Edition Health Plan Report Card, which includes data from Measurement Year (MY) 2024.

2025-26 Edition HEDIS® Updates

Overview of Changes

Below are the updates to the Health Plan Report Card HEDIS®1 measures for MY 2024:

- The following topics were renamed: (1) Maternity Care to Prenatal Care, (2) Preventive Screenings to Preventive Care, and (3) Treating Children to Child Care.
- PCR (Preventing Hospital Readmission After Discharge) was moved from the topic Appropriate Use of Tests, Treatments and Procedures to the newly added topic Hospital Readmissions.
- The HEDIS® measure abbreviation for *Controlling Blood Sugar for People with Diabetes* was updated from HBD to GSD.
- COL (Colorectal Cancer Screening) was retired for HEDIS® MY 2024 and replaced with COL-E, an Electronic Clinical Data Systems (ECDS) measure.
- ADD (both Starting Care for Attention Deficit Hyperactivity Disorder and Ongoing Care for Attention Deficit Hyperactivity Disorder) was retired for HEDIS® MY 2024 and replaced with ADD-E, an ECDS measure.
- SPR (*Testing Lung Disease*) was retired for HEDIS® MY 2024 and removed from the measure set.
- The following new measures were added to the measure set:
 - KED (Topic: Diabetes Care): Kidney Health Evaluation for People with Diabetes
 - Indicators: 18-64, 65-75, 76-85, Total
 - o PRS-E (Topic: Prenatal Care): Immunizations for Pregnant People
 - Indicators: Influenza, Tdap, Combination
 - o WCV (Topic: Child Care): Child and Teen Well-Care Visits
 - Indicators:
 - Children's Well-Care Visits: 3-11

- Teen's Well-Care Visits: 12-17, 18-21
- Child and Teen Well-Care Visits: Total

2025-26 Edition CAHPS® Updates

OPA did not incorporate any changes related to the Consumer Assessment of Healthcare Providers and Systems (CAHPS®⁴) measures into the 2025-26 Edition.

Planned Label Changes in Fall 2025

Due to technical limitations, OPA is limiting the labels shown when there is not enough information to report a Health Plan Report Card star rating or bar chart score.

For Fall 2025, the 2025-26 Edition Health Plan Report Card will be updated to align with the new Medical Group Report Cards to use a single label when there is not enough information⁵:
